1. The Ministry of Environment & Forests (MoEF), Govt. of India has received a loan / credit from the World Bank. The West Bengal Pollution Control Board, the Executing Agency for the State of West Bengal, intends to apply a part of the proceeds of this loan / credit for payment under the contract for the consultancy services "External Audit of Project Financial Statements."
2. Period of assignment is 1 year and may be extended up to another year on satisfactory performance. Firms are required to submit EOI which will be evaluated and short listed.
3. The West Bengal Pollution Control Board now invites applications from the firm of Chartered Accountants empanelled with the office of Comptroller and Auditor General of India (C&AG), Major Audits, to express their interest in carrying out the financial audit for the expenditures under this project and to indicate their interest in providing the above mentioned Services. Firms are also requested to send their detailed CV providing details about; the name, address and contact nos of the firm including information about branch offices and the year of establishment, number of partners, their experience and years of association with the firm, annual turnover of at least 3 previous financial years, experience of the firm in carrying out similar assignments etc. (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications. [The "Association" may take the form of a joint venture (with joint and several liability) or of a sub-consultancy].
4. Consultants will be selected under CQS method in accordance with the procedures set out in the World Bank's Procurement Guidelines: *Selection and Employment of Consultants by Bank Borrowers* 7May, 2004, revised October 2006 and May 2010.
