For Procurement of *Laboratory Equipment* : A) GC (MSMS), B) Headspace Autosampler, C) Pre-Concentrator, D) Sample Concentrator for evaporation of organic solvents, E) Purge & Trap Concentrator , F) Hand Held X-Ray Fluorescence Apparatus ,G) Infra Red Spectrometer in West Bengal

1. This invitation for bids follows the general procurement notice WB2018 for this project that appeared in United Nations' *Development Business* on 08.05.2010.
2. The Ministry of Environment & Forests (MoEF), Govt. of India has received a loan from the International Bank of Reconstruction and Development (IBRD) and credit from the International Development Association (IDA) towards the cost of Capacity Building for Industrial Pollution Management Project (CBIPMP) for strengthening the environment management capacity of Central and State level regulatory authorities with emphasis on rehabilitation of polluted sites. The West Bengal Pollution Control Board, the Executing Agency for the State of West Bengal, intends to apply a part of the proceeds of this loan /credit for payments under the contract for procurement of laboratory equipment as described above.
3. The West Bengal Pollution Control Board now invites sealed bids from eligible and qualified bidders to procure the laboratory equipments as mentioned above. Qualification requirements are mentioned at section – III of the bid document.
4. Bidding will be conducted through the International Competitive Bidding (ICB) Procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, Revised Oct' 2006 and May 2010 and is opened to all Eligible Source Countries as defined in the Guidelines.
5. A complete set of bidding document in English may be purchased by interested bidders on the submission of a written application to the address above and upon payment of a non-refundable fee of ₹ 1000 or US\$ 20 by Demand Draft in favour of "**West Bengal Pollution Control Board**". However Interested bidders may download the same from our **Websites: www.wbpcb.gov.in** and bidder must enclose such nonrefundable fee of ₹ 1000/- or US\$ 20 along with bid submission document. The bidding document shall be available for sale **from 19th Dec '12 to 29th Jan 2013. Pre bid meeting will be held on 07.01.2013 at 10.00 a.m** at above mentioned address . The document will be sent by airmail/surface mail/courier. The bidding document will be revised according to the minutes of the pre-bid meeting if required and will be published in the web site of the Board within three working days of the pre-bid meeting. Bidders must download the revised bidding document in this case and submit their bids accordingly.
