## INVITATION FOR BIDS (IFB) UNDER NATIONAL COMPETITIVE BIDDING (NCB)

For Remediation / Closure and Containment of Dhapa Municipal Dumpsite in Kolkata, West Bengal

1. This invitation for bids follows the general procurement notice WB2018 for this project that appeared in United Nations' Development Business on 08.05.2010. The Ministry of Environment & Forests (MoEF), Govt. of India has received a credit from the International Development Association / loan from the International Bank for Reconstruction & Development towards the cost of CBIPMP Project and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding is open to all bidders from eligible source countries as defined in the IBRD Guidelines for Procurement. Bidders from India should, however, be registered with the Government of West Bengal or other State Governments/Government of India, or State/Central Government Undertakings. **Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidders to qualify for the award of the contract.**

2. The West Bengal Pollution Control Board (WBPCB), Kolkata invites bids for the construction of works detailed in the table. The bidders may submit bids for all of the following works.

3. Bidding will be conducted through the National Competitive Bidding (NCB) Procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, Revised Oct' 2006 and May 2010 and is opened to all Eligible Source Countries as defined in the Guidelines.

4. A complete set of bidding document in English may be purchased by interested bidders on the submission of a written application to the address above and upon payment of a non-refundable fee of ₹ 10000 by Demand Draft in favour of "West Bengal Pollution Control Board". However Interested bidders may download the same from our Websites: [cbimp.wbpcb.gov.in](http://cbimp.wbpcb.gov.in) or [www.wbpcb.gov.in](http://www.wbpcb.gov.in) (select CBIPM Project) and bidder must enclose such nonrefundable fee of ₹ 10000/- along with bid submission document. The bidding document shall be available for sale from **26th Feb '14 to 4th April 2014.**

5. A pre-bid meeting will be held on **12th March 2014; IST 11.00 hours** onwards at above mentioned address to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document.

6. The document will be sent by airmail/surface mail/courier on payment of an extra amount of Rs. 1,000/- by demand draft. The bidding document will be revised according to the minutes of the pre-bid meeting if required and will be published in the web site of the Board within three working days of the pre-bid meeting. Bidders must download the revised bidding document in this case and submit their bids accordingly.
